**Title of Procedure: Development, Supply and Testing of
a Galileo Open Service Authentication User Terminal (OS-NMA) for the GSA,
Publication Reference: GSA/OP/23/16**

Date: 12 April 2017

(i) Section II.1.3 of the Contract Notice shall read "Services"

(ii) Section 1.2 of the tender specifications shall read:

"1.2 Outline of the invitation to tender and procedural process

Name: GSA/OP/23/16 - "Development, Supply and Testing of a Galileo Open Service Authentication User Terminal (OS-NMA) for the GSA"

Procedure: **Open procedure** in accordance with Article 104(1)(a) FR for procurement of services and supplies under a single service **conditional stage-payment contract (CSPC)**¹.

The GSA reserves the right to launch an exceptional negotiated procedure for new services with the same contractor in case of need, as foreseen in Art. 134(1)(e) RAP."

(iii) Section 1.2 of the tender specification, first bullet point of paragraph "IMPORTANT NOTE" shall read:

"• Unless specified otherwise under the legal capacity requirements L2 in section 3.2.1, participation in the tendering procedure shall be open on equal terms to all natural and legal persons coming within the scope of the Treaties of the European Union and to all natural and legal persons from the following third countries which have a special agreement with the European Union in the field of public procurement, applicable to the GSA under the conditions laid down in that agreement: Iceland, Norway, Liechtenstein, Switzerland, FYROM (former Yugoslav Republic of Macedonia), Albania, Montenegro, Serbia and Bosnia and Herzegovina."

(iv) Criterion L2 in section 3.2.1 shall read:

"Specific requirement – coming under the scope of the TFEU or a third country with a special agreement for participation

Coming within the scope of the Treaties of the European Union or from a third country which has a special agreement with the European Union in the field of public procurement, applicable to the GSA under the conditions laid down in that agreement: Iceland, Norway, Liechtenstein, Switzerland, FYROM (former Yugoslav Republic of Macedonia), Albania, Montenegro, Serbia and Bosnia and Herzegovina."
